PERSONAL DATA APPLICATION FORM

EXCLUDED MATTERS

As the circumstances below are not covered by the LPPD, there shall be no right to make applications concerning them:

- a) process of personal data for activities committed by real persons in connection with the applicant or his family members living in the same household, provided that such data shall not be disclosed to third parties and obligations regarding data security are complied with;
- b) Process of personal data for research, planning and statistical purposes by anonymizing them through official statistics;
- c) Process of personal data for the purposes of art, history, literature or science or freedom of expression, provided that such process shall not jeopardize national defence, national security, public security, public order, economic security, privacy of personal life or personal rights or shall constitute a crime;
- d) Process of personal data for preventive, protective or intelligence-related operations run by public agencies and institutions licensed under the law in order to secure national defence, national security, public security, public order or economic security;
- e) Process of personal data by judicial or enforcement authorities for investigation, prosecution, trial or enforcement proceedings.

Only the right to claim damages may be exercised in circumstances below where:

- a) Personal data processing is required to prevent or to investigate a crime, ·
- b) Processing of personal data which have been made public by the personal data subject,
- c) Processing of personal data is necessary by public authorities and professional organizations with public institution status exclusively authorized by the relevant laws for audit or supervision purposes or for disciplinary investigations or prosecutions, or
- d) Personal data processing is necessary to protect the state's economic or financial benefits for budgeting, taxation or financial matters.
